Safeguarding the privacy of the personal information contained in the List of Electors is a legal requirement and is of paramount importance to Elections PEI

Section 1(s) of the Election Act provides a definition for the “list of Electors” as follows:

“List of Electors” means the preliminary list of electors, supplementary list of electors or the official list of electors, as the context requires.

Section 129.1 of the Election Act states it is an offence for anyone to use all or part of the list of electors for any purpose unless the list or part of the list is used by a registered party, a member of such party or a member of the Legislative Assembly for the purpose of communicating with the electors, including the solicitation of contributions and campaigning.

Prior to obtaining access to the List of Electors, the candidate or their representative must read and sign this document indicating they understand the legal requirements to receive a list of electors.
